## **Annexure 1 – Terms and Conditions**

- 1) These Terms and Conditions are in addition to the Cabcharge Terminal Supply Agreement which between you and your Network.
- 2) These Terms and Conditions only govern the management of your individual Operator details and direct payment to you of all monies processed through the electronic payment terminals used in your vehicles (**EPTs**).
- 3) You must obtain consent from your relevant Network Operator for monies to be deposited directly into your bank account. This agreement is only effective and Cabcharge will not deposit monies directly into your bank account unless your network has signed the Network Consent Form attached at Annexure 2.
- 4) All information provided to Cabcharge must be true and correct.
- 5) You must provide all relevant information to Cabcharge pertinent to the setup and maintenance of the Momentum system on behalf of your network and to each of your owners, operators and/or drivers as the case may be and that all information must be true and correct.
- 6) For the purpose of administration of Momentum, you grant permission to Cabcharge to communicate directly, and without additional prior consent, with your drivers.
- 7) You agree that Cabcharge may charge you a market value rental for the maintenance of each EPT, installed in your Taxicabs, not to exceed \$10.00 per period per EPT, and which fees may be deducted from the funds owing to you each period.
- 8) The agreement between you and Cabcharge to deposit monies into your bank account is effective until terminated. This agreement will terminate automatically:
  - a. By mutual consent of both parties;
  - b. Without notice from Cabcharge if you fail to comply with any provisions of this agreement;
  - c. On termination of the Cabcharge Terminal Supply Agreement; or
  - d. If your network withdraws its consent.
- 9) These Terms and Conditions may be amended from time to time in Cabcharge's sole discretion.
